

LIMITED WARRANTY POLICY

SKY TEAM CANADA MOTOR CORP.

WARRANTY VALID ONLY IN CANADA

Sky Team Canada Motor Corp. agrees that it will, without charge to the owner, replace any part(s) found not to be free, under normal use and recommended maintenance, from defects in material and workmanship, subject to the following terms and conditions.

WARRANTY PERIOD

For the period of six months from the date of original retail purchase from an authorized dealer, Sky Team Canada Motor Corp. warrants that vehicles distributed in Canada that fail to function properly under normal use due to manufacturing defect when operated and maintained according to the owner's manual included with the unit will be repaired without charge to the registered owner for parts and labour. Parts supplied under this warranty may be new or rebuilt at the option of Sky Team.

LIMITATIONS

This warranty shall not apply to, or include any of the following;

- a) Repair or replacement required not as a result of defects in material or workmanship of the Manufacturer but as a result of (i) accident, (ii) misuse or abuse, (iii) lack of proper maintenance, (iv) repairs improperly performed or replacement parts improperly installed by any person other than an Authorized Dealer or the Distributor, (v) a replacement part or accessory not conforming to the Manufacturer's specifications, (vi) usage of any fuel other than that specified for the vehicle, (vii) modification or remodeling (viii) deterioration due to normal use and exposure, or (ix) damage and corrosion from environmental conditions such as airborne fallout, salt, sand, stone, hail, windstorm, lightning, flood and the like.
- b) Any Vehicle used for competition racing or related purposes.
- c) Any Vehicle which is used in any trade or business, or in an industrial or commercial application.
- d) Any warranty claim that is sought after the period where first service from an authorized Sky Team Dealer should have been performed, but was neglected.
- e) Any equipment subject to normal wear and tear, including, without limitation, filters, spark plugs, clutch facing, clutch plates, brake linings, levers, cables, bearings, gaskets, graphics, headlights, battery, tubes, tires, chains, sprockets, related adjustments, and the like.
- f) Vehicle's scheduled maintenance or other normal maintenance service, including, without limitation, cleaning, lubrication, and engine tune-up.
- g) Any expense relative to transportation to and from an authorized Sky Team Dealer or the Distributor.
- h) Any consequential, indirect or incidental loss or damage, such as loss of use, inconvenience or commercial loss.
- i) Any claims relating to the Vehicle which result from failure to execute the required maintenance and repair
- j) Vehicles that an Insurance Company has declared as a "total loss", i.e., "written off".
- k) The reimbursement for parts or labour which would be otherwise provided without charge under this warranty, obtained from any source other than a Sky Team Authorized Repair Facility or other designated location.
